## USA teams, Mexico-A and Canada-B in men's semifinals at North Bay

NORTH BAY, Canada, August 8, 2015. – The two teams from United States, Mexico-A and Canada-B will play in the men's semifinals of the third stop of the 2015 NORCECA Beach Volleyball Tour at the Canor Molsons Sand Centre at North Bay.

Ian Satterfield and Miles Evans United States will face fellow countrymen Mark Burik and Curt Toppel in one of Sunday's semifinals, while Pan-American champions Lombardo Ontiveros and Juan Virgen from Mexico will meet Samuel Pedlow and Grant O'Gorman of Canada-B.

A beautiful sunny day with clear skies closed with thrilling men's qualifiers amongst United States and Canada teams, both extending to three sets with challenging rallies.

Debuting in the NORCECA Tour, Satterfield /Evans of USA-A downed Canada's A duo of Garrett May and Daniel Dearing 2-1 (21-12, 20-22, 15-13) to make it into the final four; Dearing played with difficulties due to a knee injury. "We are ecstatic" said Ian Satterfield, "Miles and I have worked very hard and it's nice to have our efforts paying off" he added.

United States' Mark Burik and Curt Toppel battled strong against Aaron Nusbaum and Michael Plantinga (CAN-C) with both teams not giving away any point. Burik/Toppel reached the semis with a 2-1 (20-22, 21-19, 19-17) win over Nusbaum/Plantinga.

Curt Burik said "it was really tough; they had us off balance in our defense that we had to try different things throughout the match. We pulled out the win because we kept on going".

Lombardo Ontiveros and Juan Virgen of Mexico-A had a somewhat easy day; first they topped Pool A without finishing the match against Garrett May and Daniel Dearing of Canada-A as Dan suffered a minor knee injury; and then they beat Simon Fecteau-Boutin/James Battiston of Canada-D in quarterfinals 2-0 (21-11, 21-11).

"It's our first NORCECA event of the year and we are very glad to be here; we are constantly preparing for more challenges and the rest of the season, just like every team here. We have been playing focused in our strategies and hope to continue doing so" said Ontiveros.

With more experience, Canada-B of Samuel Pedlow and Grant O'Gorman won the quarterfinal match to Sergio Figueroa and Daniel Rivera of Puerto Rico 2-0 (21-9, 21-14). Earlier in the day Pedlow/O'Gorman topped Pool D defeating Burik/Toppel of USA-B 2-0 (21-17, 21-16).

Grant O'Gorman indicated "we're pleased to be our twelfth NORCECA semifinal; we have been playing well with Sam for the past weeks and we expected this result".

## Equipos de EUA, México-A y Canadá-B en las semifinales de North Bay

NORTH BAY, Canadá, 8 de agosto de 2015.- Los dos equipos de Estados Unidos, México-A y Canadá-B jugarán en las semifinales de hombres de la tercera parada del Tour NORCECA 2015 de Voleibol de Playa en el Centro de Arena Canor Molsons de North Bay.

Ian Satterfield y Miles Evans de Estados Unidos se enfrentarán a sus compatriotas Mark Burik and Curt Toppel el domingo en una de las semifinales, mientras que los campeones Panamericanos Lombardo Ontiveros y Juan Vírgen de México se medirán ante Samuel Pedlow y Grant O'Gorman de Canadá-B.

Un hermoso día de sol y cielo despejado cerró con juegos emocionantes entre los equipos de Estados Unidos y Canadá, ambos extendiéndose a tres reñidos sets.

Haciendo su debut en el Tour NORCECA, Satterfield /Evans de EUA-A se impusieron a la dupla canadiense de Garrett May y Daniel Dearing 2-1 (21-12, 20-22, 15-13) para estar entre los cuatro finalistas; Dearing jugó con dificultades por lesión de una rodilla. "Estamos eufóricos" dijo Ian Satterfield, "Miles y yo hemos trabajado fuertemente y es muy satisfactorio ver los resultados de nuestro esfuerzo" agregó.

Mark Burik y Curt Toppel de Estados Unidos batallaron con potencia ante Aaron Nusbaum y Michael Plantinga (CAN-C), ambos equipos no cedían ningún punto. Burik/Toppel avanzaron a la semifinal con triunfo de 2-1 (20-22, 21-19, 19-17) sobre Nusbaum/Plantinga.

Curt Burik dijo "fue un juego muy reñido, supieron mantener nuestra defensa fuera de base, haciendo que probáramos diferentes estrategias durante el juego. Ganamos sencillamente porque jamás nos dimos por vencidos".

Lombardo Ontiveros y Juan Virgen de Mexico-A tuvieron un día relativamente sencillo; primero ganaron el Grupo A sin tener que finalizar el juego ante Garrett May y Daniel Dearing de Canadá-A porque Dan sufrió una leve lesión en la rodilla; luego derrotaron a Simon Fecteau-Boutin/James Battiston de Canadá-D en cuartos de final 2-0 (21-11, 21-11).

"Este es nuestro primer evento del año en el Tour NORCECA y estamos muy contentos de estar acá; al igual que el resto de equipos, estamos en constante preparación para enfrentar los retos de lo que resta de la temporada. Nuestro desempeño ha sido a base de concentración y de estrategias, esperamos continuar así" dijo Ontiveros.

Con mayor experiencia, el equipo B de Canadá de Samuel Pedlow y Grant O'Gorman triunfaron en el juego de cuartos de final frente a Sergio Figueroa y Daniel Rivera de Puerto Rico 2-0 (21-9, 21-14). Previamente, Pedlow/O'Gorman finalizaron primeros en el Grupo D venciendo a Burik/Toppel of USA-B 2-0 (21-17, 21-16).



Grant O’Gorman indicó “estamos complacidos de estar en nuestro doceavo juego semifinal en el Tour NORCECA; hemos estado jugando bien con Sam durante las últimas semanas y esperábamos este resultado”.


